Policies and Guidelines

According to the UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, Ragging constitutes one or more of any of the following:

Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of color, race, religion, Caste, ethnicity, gender (including transgender), sexual orientation, appearance, Nationality, regional origins, linguistic identity, place of birth, place of residence or economic background. Any act or abuse by spoken words, emails, posts, social networking posts, e-posts.

Under the able guidance of the Principal, Dr. Gauri Rane the cell has prepared the policies and guidelines for the students.

Cell against ragging Policy:

- To uphold and comply with the directions of the Hon'ble Supreme Court and be vigilant on any acts amounting to ragging;
- To encourage socialization of students to the academic environment of the Institution. Simultaneously discouraging and preventing any negative acts on parts of students, which goes against the basic purpose of socio- academic integration;
- To create, develop and nurture conducive, socio-academic environment within the students;
- To generate and maintain a high level of confidence within newly admitted students;
- To create an environment conducive for teaching and learning;

- To conduct workshops against ragging menace and orient the students;
- To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls;
- To address any ragging issues immediately and taken action as advised by the committee;
- To display cell against ragging posters at prominent places in the campus.

Cell against ragging guidelines:

- Ragging within or outside of the institution and within the premises of the college/department/classroom is strictly prohibited.
- In order to prevent such activity in campus, Cell against ragging committee has been developed and brought into operation.
- The Cell against ragging must take immediate action on any information of the occurrence of ragging.
- The students can immediately contact the secretary/member of the Cell against ragging committee and give the complaint in writing or orally.
- Anyone found guilty of ragging and abetting ragging whether actively or passively, being a part of conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations 2009 as well as under the provisions of any penal law for the time being in force.
