- 2. You are requested to apply for eligibility certificate to the Research section of this university within Six Months from the date of issue of this letter. The Six Monthly progress Report should be submitted date to date in time i.e. from the date of approval of research title. (Ph.D. Guidelines 2017, Annexure- V).
- The students are required to submit a copy of all Six Monthly Progress Reports signed and duly endorsed by guide at the time of permission for submission of synopsis in the University.
- The candidate should pay tuition fee as well as other fees regularly in time. The fee structure and late fee, during the Process for Ph.D. degree will be as prescribed by the University authorities from time to time.
- The candidate should submit a photocopy/ hard copy of this letter to the Research Section of the University immediately after the receipt.
- If the affiliated colleges/ Institutes where the research center/laboratory are not recognised, it is mandatory for the research guides from the affiliated colleges/Institutes to get recognition to their research center/laboratory within six months from the date of issuance of this letter
